



## The Winnetka Before- and After – School Program

The Winnetka Before and After-School program is a fee-based, not-for-profit program established by the community to provide high quality, reasonably priced before- and after-school care for elementary school children in Winnetka. The program offers a safe, nurturing environment that emphasizes recreation to balance the school day’s educational activities. Children play outside or in the gym, relax, and enjoy fun activities as well as complete their homework. A simple breakfast is provided for children in the morning session; an after-school snack is provided for children in the afternoon session. There is a supervision ratio of 2 staff members for the first 24 children and a 1:12 ratio thereafter.

### PROGRAM LOCATION

The Winnetka Before and After-School Program is located at Crow Island School (1112 Willow Rd). Greeley and Hubbard Woods students are invited to enroll at the Crow Island location.

### PROGRAM TRANSPORTATION

Bus transportation will be provided from Crow Island in the AM and from Greeley and Hubbard Woods in the PM to Crow Island. There is a yearly fee for the bus transportation: \$376 for the 1<sup>st</sup> rider; 334 for the 2<sup>nd</sup> rider. Etc. There is a \$50 late fee assessed for late registrants. The bus fee is reduced by half if the child rides one way only to or from Crow Care.

For families using vouchers, there is an extra \$5.00 fee for bus transportation. Please call the District 36 office for more information.

### PROGRAM HOURS

Before School Session: 7:00 AM to 8:25AM (when regular school supervision starts)  
After School Session: 3:15 PM to 6:15 PM

(These hours represent the maximum available. Families using the drop-in option should confirm the hours when making reservations). The program will be open when the Winnetka Public Schools are in session, with the exception of the first day of school and conference days. The Winnetka Park District provides high-quality recreational programs during the summer to ensure continuity of childcare in the community.

### “DROP-IN” CARE

“Drop-in” Care will be available on a limited basis by purchasing non-refundable vouchers of 5 sessions to be used at any time in the school year. For children to be eligible for drop-in care, parents must complete the entire enrollment packet and submit the family registration fee. Drop-in arrangements also must be made at least 24 hours in advance. Parents may purchase multiple vouchers; however, unused vouchers will not be reimbursed.

### KINDERGARTEN CARE

Morning kindergarten students may enroll in the Before-School Program and afternoon kindergarten students may attend the After – School Program. Parents of kindergarten students please note: There will be no Before and After -School Program on Conference reporting days for grades 1-8.
